Opening:

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

Council Member Gene Potter made a motion to open the meeting with flexibility, Member Bruce Eagleson seconded the motion. Motion carried.

CLERK: Presented a permit authorization for Salvadore Castro to put up a carport. Jason Boggs stated that Mr. Castro has an outstanding issue with the Code Violation office. The council stated that they could not approve the permit until the issue was cleared.
