**Opening:**

Paulus then requested that the council approve changing the St Dept hours to 6-2 due to the extreme heat. Member Hoover made a motion to approve the request and change the hours until fall. Member B. Eagleson seconded the motion. Motion carried.

**Cemetery:** Working on patching asphalt and making improvements around the cemetery. Also helped at the park by fixing picnic tables.

**Park:** Working on keeping the grounds cleaned.

**ATTORNEY:** Working with LoraLee Taylor on the parking lot

**CLERK:** Presented a transfer of appropriations resolution. Member Kenner made a motion to approve the transfers, Member B. Eagleson seconded the motion. Motion carried.
