**Opening:**

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

Member Greene made a motion to purchase the vehicle and equipment. Member M. Eagleson seconded the motion. Motion carried.

Hoses have been tested, with one failure. New hose will be needed

POLICE: Marshal Snyder thanked the street department for the use of barricades. Also presented Officer Tony Clark and the new K-9 Officer Esko. The K9 assigned to Officer Sprunger will now be retired. He was in service from 2004-2011.


**ALLOWANCE OF CLAIMS**
