The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

**Council Members Present:** Raymond Hoover, Fred Romer, Carolyn Glick, Catie Gayheart and Diane Cameron

President Hoover opened the meeting at precisely 7:00 pm.

Member Romer motioned to approve the agenda with flexibility, Member Glick seconded the motion. Motion carried.

Council Member Romer made a motion to approve the July 20, 2020 minutes, Member Gayheart seconded the motion. Motion carried.

**WATER:**

- Working on the Chlorine feed system and obtaining a back up system in case of future failures. Received quotes for a chlorine pump.

Member Romer made a motion to approve the emergency purchase of a pump for \$1800.00. The pump was needed next day so the department didn't need to call a boil order for all users. Riegling will also be applying to the RDC Commission for a Façade Improvement Grant. A meeting of the RDC Commission was set for Monday, August 17<sup>th</sup> at 6:30pm.
